1. Caprock Permian Crude, L.L.C. ("Caprock") – From Points of Origin in Reeves County, Texas to Highway 285 Central, Reeves County, Texas
2. Plains Pipeline, L.P. ("Plains") – From Highway 285 Central, Reeves County, Texas to Midland Station, Midland County, Texas

Gathering and truck unload services performed in association with the movements contained herein will be assessed charges for such service as set forth in Caprock's local tariff, Texas R.R.C. No. 1.0.0, and reissues thereof.

Exceptions to Rules and Regulations Tariff, Plains' Texas R.R.C. No. 139.10.0, and reissues thereof:

In lieu of the provisions stated in Rule 31E of Plains' rules and regulations tariff, the following will apply: For joint movements on Plains' pipeline system from Highway 285 Central to Destination, the deduction for incremental evaporation and shrinkage shall be determined in accordance with the following table:

<u>API Gravity, Degrees</u>	<u>Deduction for Incremental Evaporation & Shrinkage</u>
Less than 60.0	0.0%
60.0 through 74.9	5.0%
75.0 and above	10.0%

In addition to the provisions stated in Rule 34 of Plains' rules and regulations tariff, the following policy will apply: For movements on Caprock's system, Section 5, Priority and Proration, of the Rules and Regulations published in Caprock Permian Crude LLC's Texas R.R.C. No. 1.0.0, and reissues thereof, shall apply.
